# Cypress Forest PUD Report - Greg DiCioccio:

Mr. DiCioccio noted that work would begin on the camera inspection of Champion Forest Sections 4 and 5 sewer lines in November. This is in preparation for maintenance repairs next year. He reminded those present that access would be needed to residents' backyards for the work.

Ms. Matthews asked about the JAL inspections of water meters in the subdivision, and it was confirmed this is a required county wide inspection of older water meter piping checking for metals that could be an issue. Mr. DiCioccio noted that it is unlikely that any of our meters are problematic.
