Contract Deputy Report - Sgt. Michael Gonzales:

Sgt. Gonzales gave a review of activity across the district in the month of November.

COMMITTEE REPORTS:

Architectural Control Committee – Mark Warpmaeker:

Reported:

- Eighteen ACC approval applications have been submitted since the last meeting with all but one being approved. The one denial was due to lack of requested information being submitted.
- Mr. Warpmaeker commented that residents seem to have difficulties locating their property surveys.
 Mr. Cox reiterated that owners could request a digital copy from the title company they closed with if a copy cannot be located with their mortgage closing documents.
- ACC Team required replacement members to be sought.

Between Meetings

Proposal WO# 25453 Tree Trimming \$8660.28 was presented and approved.

Wall & Hardscape Committee – Bill Boyle:

Mr. Boyle reported:

- Work on the restorative repairs of our association's two gatehouses on Champion Drive at Louetta has been completed, with the exception of the necessary and expected weatherproofing of the doors which is under discussion with JH Quality.
- It was noted the copper has already begun to show oxidation and the contractor has been notified and a review is anticipated.
- The required new electric connections are also in place and a lighting proposal was approved from Monarch Landscaping for the Gatehouses.
- Proposals were presented for lighting work on the Champion Drive at the Louetta entrance monument. Both the Masonry Solutions and the Elegant Lighting proposals were approved requiring the modification of tax removal from one proposal.
- Elegant Lighting proposal #1250 approved for \$\$11,290.32
- Masonry Solutions proposal #18098 approved for \$2,875.00

Website & Community Liaison Update – Mary Matthews:

- December's article submission is a thank you to the Board for their work, our professional landscape team, and, our residents for keeping Champion Forest well cared for along with a reminder that 2025 assessment billings are in the mail and due January 1st
